- Pricing, discounts, and commercial terms
- ❖ Manufacturing processes, quality control methods, or supplier information
- Business strategies, forecasts, or customer lists
- Any other information marked as "Confidential" or reasonably understood to be confidential due to its nature or the circumstances of disclosure

Exclusions: Confidential Information does not include information that:

- Is or becomes publicly available without breach of this Agreement
- ❖ Was lawfully known to the Receiving Party prior to disclosure by the Disclosing Party
- Is independently developed by the Receiving Party without reference to the Disclosing Party's information

- * Return/Destruction: Upon the Disclosing Party's written request (or termination of discussions), return or destroy all copies of Confidential Information (including electronic files) and certify compliance in writing.
